

**NOTICE OF FILING OF APPLICATION  
UNDER THE U.S. DEPARTMENT OF LABOR'S  
TEMPORARY EMPLOYMENT CERTIFICATION PROGRAM**

An application concerning the employment of one or more alien (25) workers for the following temporary positions will be filed with the Department of Labor. This Notice of Filing will be posted for 15 consecutive business days, as directed by the U.S. Department of Labor.

Position Title: Roofing Laborers

Position Duties: Perform temporary and full-time job duties as follows: Carry roofing materials and tools from trucks and storage piles to the work area, carry gravel, bituthene rolls and shingles in a wheelbarrow to the work area/site, load rolls of rubber and insulation on the roof and roll out materials, carry and lift shingles for roofers, take measurement information provided by the roofers and make the necessary cuts, remove snow and ice from roofs to avoid roof damage, repair roofs that have snow and ice damage, repair roof damage, place ladders, remove equipment and clean tools and worksite, store tools and equipment.

Job is located in Eagle, Colorado. Light travel, transportation provided by employer from workplace to/from all job sites. Job sites may include: Eagle, Garfield and Summit counties.

Rate of Pay: \$14.54/hour + DOE (The employer will pay or exceed the prevailing wage, as determined by the US Dept of Labor).

Hours per Week: 40 (OT is possible, to be paid at \$21.81/hour + DOE).

Single workweek will be used to compute wages due. All deductions from the worker's paycheck required by law will be made. Workers will be paid every week by check.

Transportation (including meals and, to the extent necessary, lodging) to the place of employment will be provided, or its cost to workers reimbursed, by check separate from payroll, if the worker completes half the employment period. Return transportation will be provided if the worker completes the employment period or is dismissed early by the employer. In other words, if the worker completes 50% of the work contract period, employer will reimburse the worker for transportation and subsistence from the place of recruitment to the place of work by check separate from payroll.

Upon completion of the work contract period, or where the employee is dismissed earlier, the employer will provide or pay for the worker's reasonable cost of return transportation and subsistence back home or the place the worker originally departed to work, except where the worker will not return due to subsequent employment with another employer.

The amount of transportation payment or reimbursement will be equal to the most economical and reasonable common carrier for the distances involved. Daily subsistence will be provided at a rate of \$12.46 per day during travel to a maximum of \$55.00 per day with receipts.

The employer guarantees to offer work for hours equal to at least three-fourths of the workdays in each 12-week period of the total employment period.

H-2B workers will be reimbursed in the first work week all visa, visa processing, border crossing, and other related fees, including those mandated by the government (excluding passport fees).

The employer will provide workers at no charge all tools, supplies, equipment required to perform the job.
